I am grateful for our clinical research enterprise who services more than ten thousand patients on clinical trials; and the focus of Emory University and Emory Healthcare leadership in moving forward with IT modernization. The planning and implementation of Epic and OnCore has been outstanding, and I thank the administrators across campus and our Office for Clinical Research, led by <u>Robin Ginn</u>, for their steady and meticulous progress.

I am grateful for our quality improvement initiatives that are underway and showing early successes. I am thankful the Dragon Team, led by <u>Inger Garnett</u>, for committing the energy needed to streamline both our preaward and post-award processes in conjunction with RAS, OSP, and RGC. I am thankful for <u>Kim Maune</u>, <u>Marc Overcash</u>, and <u>Wil Brown</u> for taking a comprehensive look into our Research IT infrastructure and preparing recommendations for a better tomorrow.
