Dear Emory Research Community,

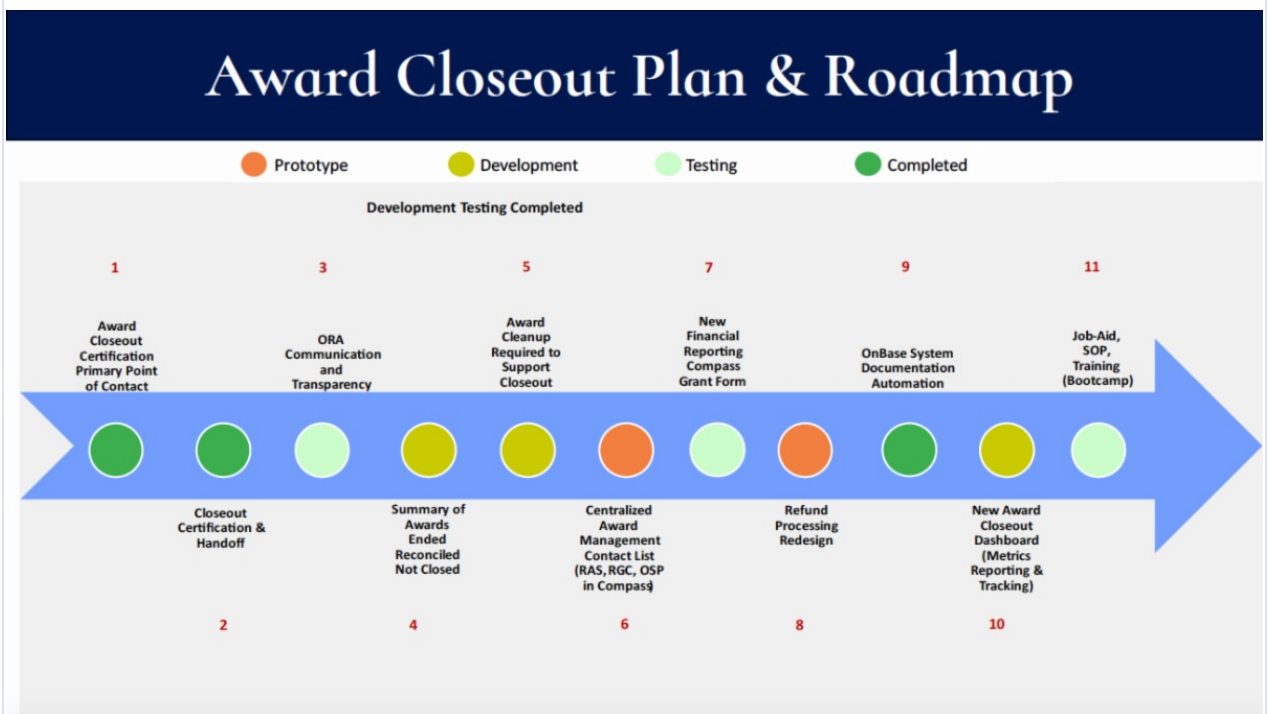

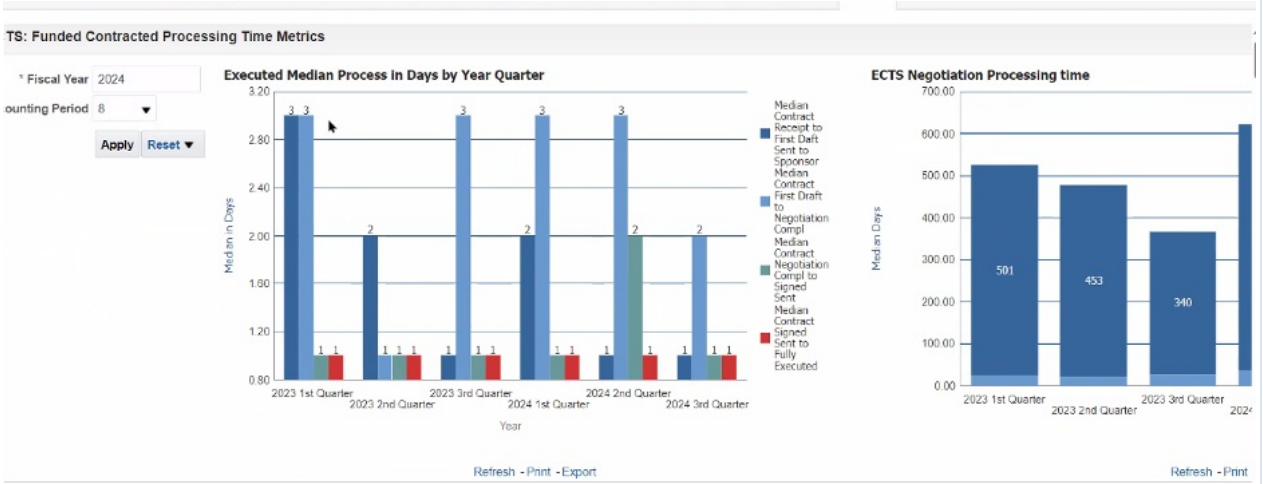

Intent, History and Launch of a Dashboard:

OSP continues to prioritize improving the contracting process to foster better internal reporting, better communication, and more transparency with the research community. With that in mind, the OSP Contracts Group partnered with ORA Research Data Analytics (RDA) and the ORA Strategic Operations and Training team (SOT) to develop the OSP Contracts Dashboard. The Contracts Dashboard is a database platform built within EBI that pulls data from the electronic Contracts Tracking System (ECTS) and Compass to provide the ability to generate robust contracts data to the Research Community.

Federal Agency Updates

NIH Boosts Pay for Postdocs and Graduate Students

The U.S. National Institutes of Health (NIH) announced pay increases today for early-career scientists who are recipients of its Ruth L. Kirschstein National Research Service Awards (NRSAs), after an [NIH advisory group recommended raises in December 2023](#). Postdocs will now be paid at least \$61,008, an increase of \$4500 over their current minimum salary level—though still below the advisory group’s recommendation of \$70,000. Graduate students will receive a \$1000 raise, bringing their minimum to \$28,224. NIH also announced a \$500 increase in child care subsidies for early-career researchers who are parents.

NSF is pleased to announce that the NSTC-approved Common Forms for the Biographical Sketch and Current and Pending (Other) Support, which are compliant with the new NSF *Proposal and Award Policies and Procedures Guide* (PAPPG) (NSF 24-1), are now available in [SciENCv](#). These revised formats will be required for proposals submitted or due on or after May 20, 2024. While these revised formats cannot be uploaded to Research.gov or Grants.gov until May 20, 2024, NSF encourages proposers to become familiar with them in preparation for proposal submission in May.

The [NSF 2024 PAPPG](#) and its updated guidelines go into effect for all proposals with due dates on or after May 20, 2024. If you submit a proposal before May 20, 2024, that has a due date on or after May 20, 2024, you will need to follow the new guidance.

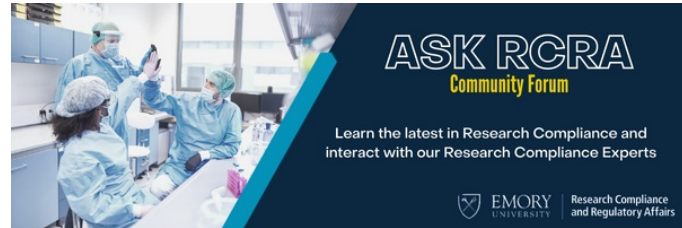
